Rainscreen Quotation Terms & Conditions of Sale

Pricing and design services

Quoted prices are based on a single bulk order for the entire contract being received, and will be valid for a period of 30 days from the date of our quote. They are based on the support grid and panels being manufactured in phases of 250/m2. Smaller sizes will incur a supplement of £ 250.00.

All project prices are for size and quantity stated, any variation to final site dimensions or phase site schedules may alter the sheet optimization and the wastage factor. Where such changes are made we reserve the right to requote. Our quote includes design and drafting services of our standard rainscreen systems only. Eltherington will notify the client and quote where appropriate for any requirement outside of these terms.

The quote assumes standard operating hours within our factory and an agreed schedule issued to us to enable manufacture within appropriate timescale. Should out of hours manufacturing be required to meet the issued programme, or changes made to accelerate the plan, or changes made through no fault of Eltherington Aluminium, we reserve the right to charge all costs as an extra over to the price quoted.

Delivery

The delivery lead-time stated on our project quote will start from receipt of the full bulk order and panel take-off. Our offer is dependent on a suitable production slot being available at the time of receiving the order. In the event of receiving variations to the tender, we reserve the right to review our agreed programme.

The lead times quoted are valid for 30 days from the date of our quote

Delivery charges are based on deliveries of 250/m2 and will be shown as a separate line on your project quote, unless specifically required to include it in the /m2 price. Additional deliveries will be charges as an extra over. All deliveries will be made on our standard fleet unless we are notified in advance; no special delivery vehicle or conditions have been allowed for, and will be charged as an extra over to the price quoted.

Site off-loading and storage is the sole responsibility of the buyer. All panels and profiles should be stored on level ground and kept dry.
